The Chair of the PCC may invite officials/technical personnel from other concerned Agencies as deemed necessary.


The Committee shall provide oversight coordination on activities related to the SPLIT Project. It shall also develop operational procedures and lead the preparation of a harmonized Work and Financial Plan of the Department for the SPLIT Project. The Committee shall regularly meet in order to monitor and assess the progress and accomplishment of the activities under the SPLIT Project.

The Committee shall be assisted by the Project Secretariat from the Forest Management Bureau for all administrative and technical support.

To facilitate the implementation of the activities under the SPLIT Project, the Regional Offices concerned shall designate their respective principal and alternate focal persons (preferably the CARP Coordinator as principal and LAMS Focal as alternate) through the issuance of a Regional Special Order. The focal persons shall oversee the project implementation within their jurisdiction and facilitate coordination with the DENR Project Coordination Committee on the matters pertaining to the SPLIT Project.

All expenses to be incurred in the conduct of this activity shall be charged against the SPLIT Project Fund of the Department of Agrarian Reform (DAR), subject to the usual accounting and auditing rules and regulations.

This Order takes effect immediately.
