The members of the TWG shall facilitate the following for the pre-production, production, and post-production stages of *Our Fragile Earth: Protected Areas of the Philippines* Video Documentaries (Batch 5):

- a. Participate in online and face-to-face story conferences;
- b. Provide information on the key features of the PA;
- c. Provide assistance/guidance on the conduct of the on-camera shoot, possible personalities for the review, and a focal person on-site during the shoot;
- d. Assist in coordination such as securing the necessary permits, clearances, and logistical arrangements;
- e. Assist in coordination such as securing the necessary permits, clearances, and logistical arrangements;
- f. Review and provide comments and inputs to the draft scripts and videos, and;
- g. Provide assistance during the on-camera shoot recording of the voice-over of Senator Loren B. Legarda.

Expenses to be incurred in pursuit of this Order shall be chargeable against respective offices subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until the completion of the AVP, and the series of related works, thereafter.
