Traveling expenses to be incurred by the DENR participants, shall be charged against their respective Offices. Other expenses for the conduct of the summit such as meals and accommodation, and plane fare of Non-DENR participants, resource speaker/facilitator shall be shouldered by DENR-BMB through GAA funds and its ABS Project, subject to the availability of funds and usual accounting and auditing rules and regulations, and with financial support from the United Nation on Drugs and Crime (UNODC) and Tanggol Kalikasan.

The BMB Director is authorized to reschedule the summit, through a Memorandum, in case of conflict with other DENR programs and activities. Further, in case of unavailability of any of the above-listed participants, the BMB may invite other participants from the same region subject to the recommendation of the concerned DENR Regional Offices. The BMB is also authorized to engage participants from other relevant government agencies and non-government organizations in accordance with the approved activity design attached as Annex "A" to this Special Order.

A report shall be submitted online (bit.ly/LNDportal) to the undersigned through the Human Resource Development Service (HRDS) Training and Development Division, fifteen (15) days after the completion of the activity.
