SUBJECT: AUTHORIZING THE CONDUCT OF SERIES OF GREENHOUSE GAS INVENTORY TRAININGS ON ENERGY, WASTE, INDUSTRIAL PROCESSES AND PRODUCTS USE (IPPU), AND FORESTRY AND OTHER LAND USES (FOLU) SECTORS IN REGION 3

In the interest of the service, and in line with the commitments to the 2022 National Greenhouse Gas Inventory Cycle, the Climate Change Service is hereby authorized to conduct a Series Of Greenhouse Gas Inventory Training on Waste, Industrial Processes and Products Use (IPPU), and Forestry and Other Land Uses (FOLU) Sectors on 18 - 22 March 2024 for Waste and IPPU Sectors and 11-12 April 2024 for the FOLU Sector in Region 3.

The series of trainings aims to orient and capacitate the DENR Greenhouse Gas Inventory Team composed of Data Providers, Collectors and Analysts in preparation for the conduct of the 2022 National Greenhouse Gas Inventory, which is a critical input to the proposed submission of the Biennial Transparency Report (BTR) in 31 December 2024.

Participants are likewise required to bring their laptops and related data reports for the workshop exercises.

All expenses to be incurred in relation to the conduct of the activities shall be charged under the Climate Change Service, subject to the usual accounting and auditing rules and regulations.

The Director of Climate Change Service is authorized to adjust the date and location of the subject activity as exigencies may warrant. Any changes in the schedule shall be submitted to the HRDS for recording purposes.

A report shall be submitted online (bit.ly/LNDportal) to the undersigned through the Human Resource Development Service - Training and Development Division fifteen (15) days after the completion of the activity.
