The ENR Academy Facility personnel shall provide assistance in the administrative and logistical concerns of the training.

Should a session day fall on a holiday or a weekend, all learners, staff and resource persons shall be entitled to Compensatory Time Off (CTO) and shall be used until 31 December 2024. All expenses to be incurred in the conduct of the aforementioned course and other allowable incidental expenses shall be charged against Geospatial Database Office (GDO) funds, while traveling expenses of the participants including plane fare to and from the venue shall be charged to their respective offices subject to existing accounting and auditing rules and regulations.

The TDD-HRDS shall lead the implementation of the training workshop. The Assistant Secretary for Human Resources, Strategic Communication and Sectoral Initiatives is authorized to amend the date of the said activity in case of conflict with other activities of the Department or unavailability of the resource persons/subject matter experts.

A report shall be submitted online (bit.ly/LNDportal) to the undersigned within fifteen (15) days upon completion of the activity. Further, each learner shall accomplish and submit a Competency Development Management Form (CDMF) seven (7) days prior to the conduct of the activity.
