SUBJECT : DESIGNATION OF DENR REPRESENTATIVES TO THE INTER-CABINET CLUSTER MECHANISM ON NORMALIZATION (ICCMN)

Pursuant to Executive Order No. 79 dated 24 April 2019, entitled "Implementing the Annex on Normalization under the Comprehensive Agreement on the Bangsamoro", the following are hereby designated as the DENR's Representatives to the Inter-Cabinet Cluster Mechanism on Normalization (ICCMN) and the Sub-Clusters on Transitional Justice and Reconciliation, and Socio-Economic Development:

3. Director / Budget Division - Financial and Management Service
4. Regional Executive Director / Surveys and Mapping Division, DENR - Region XII
5. Regional Executive Director / Surveys and Mapping Division, DENR - Region X

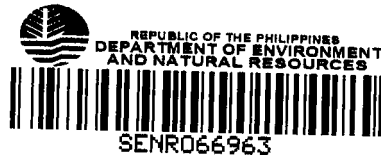
6. Division Chief, Land Classification Division, Resource Data Analysis Branch
- National Mapping and Resource Information Authority
7. Social Cartography Project Legal Team:
 - a. Claims and Conflicts Division - Legal Affairs Service
 - b. Investigation and Arbitration Division - Legal Affairs Service

As such, they shall ensure the Department's active participation in all related activities of the ICCMN and comply with the necessary requirements thereof. Furthermore, other offices of the Department shall likewise render assistance to the ICCMN *to ensure timely, appropriate and efficient delivery of the Normalization Program.*¹

Expenses to be incurred in relation to the conduct of activities shall be charged against the Department's funds, subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately.
