All expenses incurred shall be charged against the DENR Funds, subject to the usual accounting and auditing rules and regulations. Traveling expenses, i.e., plane fare, food, and accommodation during the three (3) Resource Speakers from the UN-Habitat event, shall be shouldered by the DENR.

The Director of the Climate Change Service is authorized to amend the date and venue of the said activity in case of conflict with other Department activities or the unavailability of the resource persons/subject matter experts.
