CREATION OF THE BIODIVERSITY MULTI-SECTORAL ADVISORY COUNCIL (BMSAC) TO ASSIST THE DENR ON CRITICAL ISSUES AFFECTING BIODIVERSITY AND PROTECTED AREAS SYSTEM OF THE COUNTRY

In the interest of the service, and pursuant to Section 8 (J) of Republic Act (RA) 7586 or the National Integrated Protected Areas Systems Act (NIPAS), as amended by RA 11038 or the Expanded-NIPAS, the DENR Secretary is empowered to call on any agency or instrumentality of the Government as well as academic institutions, NGOs and the private sector, as may be necessary to accomplish the objectives and activities of the System. In this regard, the Biodiversity Multi-Sectoral Advisory Council (BMSAC) is hereby created which shall provide technical inputs and expert advice to the Department on critical issues and matters affecting biodiversity and the governance of the integrated protected areas system of the country.

The members of the BMSAC shall be provided with the necessary support from senior officials of the Department in all deliberations, discussions, and meetings with regard to biodiversity conservation and protected area governance.

The BMSAC shall continuously monitor and evaluate the status of both emerging and ongoing critical issues on biodiversity and the integrated protected areas system of the country for immediate resolution, through coordination with the concerned parties, as well as the relevant offices of the Department. Further, it shall convene when exigency requires and upon call of the Secretary. It shall submit a report narrating updates on the ongoing or emerging complex or critical issue to the Office of the Secretary after every deliberation.

The Forest Foundation Philippines (FPF) shall serve as the Secretariat to support the DENR thru the Biodiversity Management Bureau (BMB) and assist in the conduct of meetings and related activities of the BMSAC. It shall also be responsible for the documentation of agreements, issuance of advisories for meetings and other arrangements.

Expenses to be incurred for the Secretariat work of the BMSAC shall be sourced by the FPF, with support from DENR funds, as necessary, subject to existing accounting and auditing rules and regulations.

This Order takes effect immediately and shall remain in force unless revoked in writing.
