**SUBJECT : DESIGNATING THE MEMBERS OF THE INTER-AGENCY COORDINATING COUNCIL UNDER ADMINISTRATIVE ORDER NO. 21 S. 2024, AND THE MEMBERS OF THE THREE (3) TECHNICAL WORKING GROUPS CREATED BY VIRTUE THEREOF**
