2. Lead the performance of the DENR's functions and commitments as provided for in the National Disaster Risk Reduction and Management Plan for 2020-2030, the National Disaster Response Plans, and other relevant national plans, issuances and references; and
3. Coordinate with and tap other DENR Offices, Bureaus/Attached Agencies and Implementing Units to participate in the activities of the NDRRMC, as necessary, based on respective mandates and specific requirements of the Council's Thematic Pillars.

All expenses to be incurred in carrying out the functions relative to this Order shall be charged against the respective office funds, subject to usual auditing and accounting rules and regulations

This Order takes effect immediately and supersedes all previous issuances inconsistent herewith.
