SUBJECT : AUTHORIZING THE CONDUCT OF HYBRID NATIONAL ORIENTATION ON THE PROCEDURES OF FORESHORE DELINEATION, INVENTORY, AND PROFILING OF IMPROVEMENTS ALONG FORESHORE AREAS NATIONWIDE EXCEPT IN THE CORDILLERA ADMINISTRATIVE REGION (CAR) AND BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM) ON OCTOBER 7-9, 2024, IN NATIONAL CAPITAL REGION (NCR)
