SUBJECT : AUTHORIZING THE CONDUCT OF ACTIVITIES IN OBSERVANCE OF THE CELEBRATION OF THE NATIONAL CLIMATE CHANGE CONSCIOUSNESS WEEK 2024

In the interest of service, pursuant to Proclamation No. 1667, s. 2008, entitled "Global Warming and Climate Change Consciousness Week" to launch an intensive information and education campaign to help reduce greenhouse gas emissions and promote behavioral solutions to climate change and a sustainable lifestyle to our communities, as well as raise awareness on the National Adaptation Plan (NAP) 2023-2050 and the National Determined Contribution Implementation Plan (NDCIP) 2023-2030, the conduct of this year's National Climate Change Consciousness Week with the theme "*Aksyon at Adaptasyon ng Makabagong Henerasyon*", is hereby authorized.


Expenses to be incurred relative to the conduct of the events from the DENR Central Office, including food, venue, accommodation, resource persons' fees, cash prizes, certificates, trophies, supplies, tokens, travel expenses of winners, supplies/materials, and other miscellaneous items shall be chargeable against the funds of the Climate Change Service and Gender and Development Office, subject to the usual accounting and auditing rules and regulations.

Offices of the DENR at the Central and Regional levels, Bureaus, and Attached Agencies are also advised to mount their respective support activities. Related activities held during weekends are considered official with one day offsetting privilege to be used until December 2024. For the DENR Central Office, attached as Annex 1 is the line up of activities.

A report shall be submitted online (bit.ly/LNDportal) to the undersigned through the Human Resource Development Service (HRDS) - Training and Development Division, fifteen (15) days after the completion of the activity.

The Director of the Climate Change Service is authorized to amend and reschedule the activity in case of conflict with other activities of the Department. Any changes in the schedule shall be submitted to the HRDS for records purposes.

This order takes effect on the dates herein specified.
