The FMB will request the participation of representatives from the Presidential Agrarian Reform Council (PARC) Secretariat, officers of the National Federation of CBFM People's Organizations (POs), representatives of participating POs and some LGUs in the Agroforestry Enterprise Development (AED) Clustering Approach. Likewise, Resource Persons from other government agencies and other CBFM Support Groups/Institutions shall be invited to discuss topics related to CBFM and CBFM-CARP.

Expenses to be incurred by all participants such as, but not limited to, food and accommodation, supplies/materials, training kits, tokens and other related expenses relative to the conduct of the activity shall be charged against FMB Fund 101 (CBFM-CARP). Traveling expenses to be incurred by the officers of the National Federation of CBFM People's Organization and representative of POs participating in the AED Clustering Approach shall be charged against FMB Fund 101 (CBFM-CARP). On the other hand, all traveling expenses and per diems to be incurred by all DENR and FMB participants shall be charged against their respective offices, subject to usual accounting and auditing rules and regulations.

The Director of the Forest Management Bureau is authorized to reschedule the activity in case of conflict with other activities of the Department.

A report shall be submitted online (bit.ly/LDNportal) to the undersigned through the Human Resource Development Service - Training and Development Division fifteen (15) days after the completion of the activity.

This Order takes effect on the dates specified therein.
