**SUBJECT: Designation of the Members of the Zamboanga City Airshed  
Governing Board**

In the interest of public service and pursuant to Section 9 of Republic Act 8749, otherwise known as the "Philippine Clean Air Act of 1999", Sections 4 and 5, Rule XV, Part V of the Implementing Rules and Regulations (DAO 2000-81) of the said Act, to effectively carry out the formulated action plans, a Governing Board is hereby created, herein referred to as the Board.

The Board shall be headed by the Secretary of the Department of Environment and Natural Resources, as Chairman, and shall have one (1) Deputy Chairperson, the Regional Director of Environmental Management Bureau, Region IX.

The members of the Board shall be composed of the following:

- a. The Provincial Governor of Zamboanga del Sur
- b. The City Mayor of Zamboanga
- c. The Regional Directors of the following:
  1. Department of Transportation and Telecommunication-Land Transportation Office
  2. Department of Health
  3. Department of Trade and Industry
  4. Department of Interior and Local Government
  5. Department of Science and Technology-Philippine Atmospheric Geophysical and Astronomical Service Administration
- d. Representatives from the private business sector, People's Organization together with the non-governmental Organizations who shall, within six (6) months from the designation of the airshed, be chosen by and among themselves through sectoral assemblies concerned. The member of representatives shall be in a ratio of 5:2:2 (Government-private-civil society).


The members of the Governing Board shall serve for a term of three (3) years (or such lesser time as may be permitted by the term of office, if publicly elected officials) without compensation except for actual and necessary expenses incurred in the performance of their duties, subject to availability of funds and the usual accounting and auditing rules and regulations.

When a vacancy occurs during the term of a member from PO, NGO or Private business sector, a new member shall be appointed by the Governing Board for the remainder of the unfinished term.

The Board shall perform the following functions:

- 1). Formulation of policies and standard-setting subject to laws of national application;
- 2). Preparation of a common action plan;
- 3). Coordination of functions among its members; and
- 4). Submission and publication of an annual Air Quality Status Report for each airshed.
