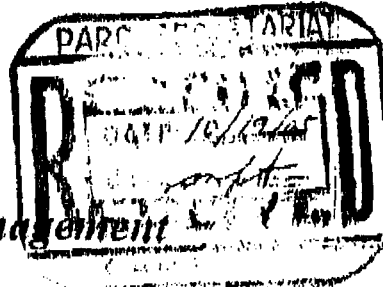

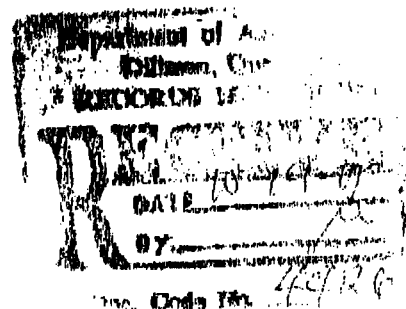

Sir:

This pertains to the request of the Presidential Agrarian Reform Council (PARC) for the extension of the authority previously granted on the renewal of the appointment/contract of casual/contractual employees hired by the Comprehensive Agrarian Reform Program-Implementing Agencies (CARP-IAs) from December 31, 2005 until such time that the CARP Rationalization Plan is ready for implementation.

The request to rehire the contractual/casual employees deployed in the CARP-IAs, i.e., DAR, DTI, DENR, LRA and NIA, is hereby approved so as not to adversely affect major on-going activities, subject to pertinent budgetary, accounting and auditing rules and regulations and the following conditions:

- That the exemption shall cover only the renewal of appointments/contracts pertaining to the actual number of casuals/contractuals of CARP-IAs as of this date;
- That the effectivity of appointments/contracts shall be up to the time that the CARP Rationalization Plan is ready for implementation, but not to exceed June 30, 2006;
- That there shall be no new hiring and/or replacement of resigned/terminated staff; and
- A report of compliance with this authority has to be submitted to the DBM.

As has earlier been communicated, may we suggest that the PARC provide the Implementing agencies with policy guidance on how they should proceed in rationalizing their respective operations with regard to CARP-related activities.
