PROCLAMATION NO. 874

**CREATING AND DESIGNATING THE CONVERGYS BUILDING SITUATED ALONG
AYALA AVENUE CORNER SALCEDO STREET IN THE BARANGAY OF SAN
LORENZO, CITY OF MAKATI, METRO MANILA, ISLAND OF LUZON, AS
INFORMATION TECHNOLOGY BUILDING PURSUANT TO REPUBLIC ACT NO.
7916 AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act No. 7916, the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, by virtue of the powers vested in me by law, do hereby create and designate as **Information Technology Building**, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, and Resolutions Nos. 00-411 and 04-279 dated 29 December 2000 and 06 September 2004, respectively, of the PEZA Board of Directors, a building henceforth to be known as the **Convergys**, which stands on a 5,868-square meter lot, more or less, located along Ayala Avenue corner Salcedo Street, Barangay San Lorenzo, Makati City, Metro Manila, as defined by the following technical descriptions:

**"LOTS 1, 3-A, 4-A & 5-A
Pcn-00-001230**

A parcel of land (as described on consolidation plan, Pcn-00-001230 being a consolidation of Lots 3-A, (LRC) Psd-10071, 4-A, (LRC) Psd-10040, 1, (LRC) Pcs-4467, 5-A, (LRC) Psd-10071, LRC Record No. 2029), situated in Barangay of San Lorenzo, City of Makati, Metro Manila, Island of Luzon.

Bounded on the NW., along line 1-2 by Lot 3-B, (LRC) Psd-10071; along line 2-3 by Lot 4-B, (LRC) Psd-10040; along lines 3-4-5 by Street Lot 1, (LRC) Pcs-536; on the NW. & NE., along lines 5 to 10 by Lot 4-C, (LRC) Psd-10040; on the NE., along lines 10-11-12 by Street Lot 1, (LRC) Pcs-536; on the SE., along line 12-13 by Lot 6, Block 1, (LRC) Pcs-536; on the SE., & SW., along lines 13 to 19 by Lot 8; on the SW., & NW., along lines 19 to 33 by Street Lot 1 (Dela Rosa St.), both of (LRC) Pcs-4467; and on the NW., along line 33-1 by St. Lot 1, (LRC) Psd-4624.
