As Undersecretary for Policy, Planning, Research and Legislative Affairs, he shall perform the following functions and assignments:

Staff Functions shall mean the Undersecretary concerned shall provide policy direction and support to the staff departments and divisions within the agency to perform their respective roles.

Sectoral Assignment shall mean the Undersecretary or the Assistant Secretary concerned shall ensure implementation of priority programs of the bureau concerned. This includes monitoring the accomplishments of the targets. Bureau Directors and the Regional Operations of these bureaus shall be directly under the control and supervision of the Secretary.

Important inter-agency Committee and other assignments shall mean representing DENR in the regular meeting and/or serving as alternate representative of the Secretary in the committee.

This Order supersedes other issuances inconsistent herewith and takes effect immediately.
