DENR Special Order

No. 2005- 296

Subject: Deputation of Lt. Col. Hernando M. Caraig, Jr., Commanding Officer, 28th Infantry Battalion (IB), Philippine Army and Subsequent Commanding Officers as Deputized Environment and Natural Resources Officer (DENRO) within Diwalwal Mineral Reservation and vicinity.

Pursuant to the provisions of DENR Administrative Order No. 41, Series of 1991 and Sections 8 and 9 of RA 7942 (Philippine Mining Act), Lt. Col. Hernando M. Caraig, Jr., Commanding Officer, 28th Infantry Battalion (IB), Philippine Army and other subsequent Commanding Officers to be appointed or assigned are hereby appointed as Deputy Environment and Natural Resources Officer (DENRO) within the Diwalwal Mineral Reservation and vicinity to exercise the power and authority provided in the aforesaid administrative orders, laws, rules and regulations under the supervision of the DENRO Officer concerned effective upon receipt of this Order.

By virtue of this deputation, he is authorized to detect/investigate violations of environment and natural resources laws, rules and regulations and to arrest even without warrant any person who has committed, is committing or is about to commit offenses in his presence in violation of environment and natural resources laws, rules and regulations within the territorial jurisdiction specified herein.

He is also authorized to apprehend the tools and equipment and conveyances used in the commission of the offense and the natural resources products extracted/cut, gathered, removed and possessed by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or apprehension, he shall deliver within the period prescribed by law from the time of arrest and apprehension, the offender/s and apprehended natural resources products, tools and equipment including the conveyance/s used, to the seizure officer of the DENR.

He is further authorized to administer oath and take acknowledgement in official matters connected with their aforementioned functions and to take testimonies in official investigation/s conducted under the authority of the aforesaid laws as amended and its implementing rules and regulations.

He shall submit to the RED of the DENR through the PENRO/CENRO concerned a monthly report of the cases he has handled and/or activities undertaken pursuant to this Order.

Upon receipt of this Order, he shall report to the PENRO/CENRO concerned to undergo the required orientation briefing on basic environment and natural resources laws, rules and regulation relative to this functions as Deputy ENRO before officially discharging his duties and responsibilities and to accept place of assignment as directed by the PENRO concerned.

This Order takes effect immediately and shall remain effective unless sooner revoked or terminated by this Office.
