3. Coordinate with the companies and closely monitor the progress of their projects and submit regular reports on the status and recommendations/actions to resolve pending issues/concerns; and
4. Prepare regular reports on the current status and developments relative to the project.

All the necessary expenses relative to the implementation of the various activities shall be charged against the regular funds of the agency.
