Subject: Establishment of Baco-Calapan City-Naujan Airshed and its Governing Board

Pursuant to Section 9 of the Philippine Clean Air Act (RA 8749) and Section 1 to 11, Rule XV, Part V of its Implementing Rules and Regulations (DENR Administrative 2000-81), the Baco-Calapan City Naujan-Airshed and its governing board is hereby created.

Section. 1 Coverage of the Airshed

The airshed covers the of northern part of Oriental Mindoro which composed of Calapan city and the municipalities of :Baco and Naujan

Section 2. Review and/or Revision of coverage of the Airshed

Pursuant to Section 1, 2, Rule XV, Part V of DAO 2000-81, upon consultation with appropriate local government authorities, the Secretary of the Department, upon recommendation of the Bureau shall, from time to time, review, revise, amend and/or expand the designation of the airshed utilizing eco-profiling techniques and undertaking scientific studies.

Section 3. Composition of the Baco-Calapan City-Naujan airshedGoverning Board

To effectively carry out the action plans, a Governing Board is hereby created, herein referred to as" the Board".

The Board shall be headed by the Secretary of the Department of Environment and Natural Resource. The Regional Executive Director of the DENR or the Regional Director of Environmental Management Bureau, Region IVB shall act as Deputy Chairperson.



Let's Go Green!

The members of the Board are the following :

- a. The Provincial Governor of Oriental Mindoro
- b. Mayors of Baco, Calapan City and -Naujan
- c. The Regional Directors of the following:
 - 1. Department of Transportation and Communication-Land Transportation Office (DOTC-LTO)
 - 2. Department of Health (DOH)
 - 3. Department of Trade and Industry (DTI)
 - 4. Department of the Interior and Local Government (DILG)
 - 5. Department of Science and Technology (DOST)
 - 6. Department of Enegy
- Representatives from the private_business sector, peoples organization (POs) together with the non-governmental organizations (NGOs) the number of which shall be in a ratio of 5:2:2 government -private civil society who shall, within six (6) months from the designation of the airshed, be chosen by and among themselves through sectoral assemblies.

Section 4. Term of Office

Members of the Governing Board shall serve for three (3) years (or such lesser time as may be permitted by the term of office, if publicly elected officials) without compensation except for actual and necessary expenses incurred in the performance of their duties, subject to availability of funds and the usual accounting and auditing rules and regulations.

When a vacancy occurs during the term of a member from PO, NGO or Private business sector, a new member shall be appointed by the Board for the remainder of the unfinished term.

Section 5. Functions of the Board

The board shall perform the following functions:

- a) Formulation of policies;
- b) Preparation of common action plan;
- c) Coordination of functions among its member; and,



d) Submission and publication of an annual air quality status report for each airshed.

Section 6. Separability Clause.

Should any provision of this Order be declared unconstitutional, the same shall not affect the validity or the legality of the other provisions.

Section 7. Effectivity

This Order shall take effect immediately fifteen (15) days from the publication in two newspapers of nationwide circulation, and shall remain in force unless repealed or revoked in writing.
