**SUBJECT : Establishing as Diteki River Watershed Forest Reserve for Purposes of Protecting, Maintaining and Improving its Water Yield and To Provide Restraining Mechanism for Inappropriate Forest Exploitation and Disruptive Landuse a Certain Parcel of Land of the Public Domain Situated in the Municipality of San Luis and Maria Aurora, Province of Aurora, Island of Luzon, Philippines**

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside, as Diteki River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a certain parcel of and by the public domain situated in the Municipalities of San Luis and Maria Aurora, Province of Aurora, as shown in the Forest Management Bureau Map WR No. 93 with the following descriptions:

Beginning at point "1" on the map is a point at the junction of a highway and Kiapo Illio River which is No. 60°00'E and 1,850 meter from the junction;

Thence S 10°00'W, 500 meters to comer 1, the point of beginning containing an area of TWELVE THOUSAND NINE HUNDRED SEVENTY 912,970.0) HECTARES, more or less.

The area covered by the reservation shall be under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources through its Forest Management Bureau in coordination with other agencies of the government with the objective of maintaining its usefulness, as a source of water for irrigation, domestic use and other forestry purposes.

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Dingalan River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as maybe determined by the Secretary of Environment and Natural Resources, a certain parcel of land by the public domain situated in the Municipality of Dingalan, Province of Aurora, Island of Luzon, Philippines as shown in the Forest Management Bureau Map No. 101 with the following descriptions:

Beginning at point "1" on the map, which is identical to FZ comer 29, alienable and disposable, project No. 39.

Thence S 86°W, 100 meters to comer 1, the point of beginning containing an area of ONE THOUSAND SEVEN HUNDRED EIGHTY EIGHT HECTARES (1,788.0).

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Cabadbaran River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a certain parcel of land of the public domain situated in the Municipalities of Cabadbaran and Santiago, Province of Agusan del Norte as shown in the Forest Management Bureau Map No. 89 with the following descriptions:

Beginning at point "1" on the map is a point at the bank of Cabadbaran River at latitude 9°7'43' and longitude 125°38'21";

Thence N. 75°00' W., 1,350 meters to corner 1, the point of beginning, containing an area of SIXTEEN THOUSAND TWENTY FIVE (16,025) HECTARES, more or less.

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Lake Lanao Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a parcel of land of the public domain situated in the Municipalities of Ditsaan-Ramain, Bubong, Buadipuso-Buntong, Molundo, Taraka, Maguing, Tamparan, Lumba-Bayabao, Poona-Bayabao, Masiu, Buteng, Lumbatan, Lumbayanagui, Bayang, Binidayan, Ganassi, Pualas, Madalum, Madamba, Bacolod Grande, Tugaya, Balingong, Marantao, Piagapo, Saguiaran and Marawi City All of the Province of Lanao del Sur, Island of Mindanao, as shown in the attached proposed Lake Lanao Watershed Forest Reserve Map No. 104, with the following description:

Beginning at point "1" on the map is a point latitude 8 degrees 03 minutes and 31.31 seconds, and longitude 124 degrees 15 minutes and 58.19 seconds at the bank of Agus River:

Thence N. 31 deg. 00'E., 3,900 m. to corner 53; to the point of beginning; containing an area of 180,460 hectares more or less.

AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Dinadiawan River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may determined by the Secretary of Environment and Natural Resources, a certain parcel of land by the public domain situated in the Municipality of Dipaculao, Province of Aurora, Island of Luzon, Philippines which is particularly described as follows:

Beginning at point "1" on the map, which is a point located at the mouth of Dinadiawan River;

Thence following shoreline in a general SW direction, 850 meters to corner 2; a point along the shoreline;

Thence following shoreline in a general southwest direction about 500 meters to corner 1, the point to beginning containing an area of THREE THOUSAND THREE HUNDRED EIGHTY SEVEN (3,387.00) HECTARES, more or less.

**SUBJECT : Establishing Subic Watershed Forest Reserve for Purposes of Protecting, Maintaining and Improving its Water Yield and Providing Restraining Mechanism for Inappropriate Forest Exploitation and Disruptive Landuse a Certain Parcel of Land of the Public Domain Situated in the Province of Bataan, Island of Luzon, Philippines**

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from sale, entry, settlement, exploitation, exploration and other forms of disposition, subject to private rights, if any there be, and set aside and declare Subic Watershed Forest Reserve to protect and preserve the rare biological diversity of the flora and fauna therein and keep intact the productive capacity of the hydrologic unit supplying the developable portions of the Subic Bay Military Reservation, a certain parcel of the public domain situated in the Province of Bataan, Island of Luzon, more specifically described as follows:

Beginning at point "1" on the plan identical to

To point of beginning, containing an approximate area of TEN THOUSAND (10,000) HECTARES.

The said parcel of land shall be part of the watershed reservation and remain under the executive control of the Secretary of Environment and Natural Resources who is hereby directed to take all necessary actions within his authority to administer and protect the above mentioned resources of the said reservation.

Any person who shall collect, cut, gather any forest products, wildlife from the said watershed area and/or in any manner destroy the biological diversity of the resource natural features therein or interfere with the sustainable functioning of the water resources shall be punished in accordance with the penalties prescribed under existing laws, rules, and regulations.

AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Kotkot and Lusaran River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a certain parcel of the public domain situated in the cities of Cebu and Danao and the municipalities of Balamban, Compostela, Consolacion, Lilo-an, Province of Cebu, as shown in Forest Management Bureau Map No. 94 with the following descriptions:

Beginning at point "1" on the map being N. 19°30' W. 875.00 meters from the junction of the Highway and Kotkot River;

Thence S. 03°36' E., 871.03 meters to point of beginning, containing an area of FOURTEEN THOUSAND FIVE HUNDRED THIRTY FOUR (14,534) HECTARES, more or less.

The area covered by the reservation shall be under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources, through its Forest Management Bureau, in coordination with other agencies of the government with the objective of maintaining its usefulness as a source of water for irrigation and domestic use and other forestry purposes.

The area reserved is subject to future survey and delineation of boundaries.
